For your sake ...

1. Checkout time is 1:00 PM. Check-in time is 2:00 PM. Please come by the office to check out or to register if you wish to stay longer.
- 2. Campground facilities are for registered campers only.**
3. Do not move fire rings.
- 4. Please bag and tie your garbage and place in dumpster at campground entrance.**
5. All guests are required to stop and register at office. You will need to pick up a guest car pass. There is a \$2 charge per person for guests. Overnight and all day guests are \$5.00 per person.
6. Parents are responsible for their children at all times. Please restrict bicycle riding to direction of traffic flow. No bicycle riding in area from entrance to office.
7. One unit and one vehicle per site.

For your neighbor's sake ...

1. PETS
 - A. Pets must be kept on a leash (not over 8 ft.) and under control at all times.
 - B. Please clean up after your pet and dispose of litter properly.
 - C. Owners must not permit their dogs to become a nuisance through barking or howling.
 - D. No large or aggressive dogs, for example but not limited to: Rottweilers, Dobermans, Pit-Bulls, Chows, etc.
 - E. Owners must present proof of current rabies vaccine at check-in.
 - F. Dogs may not be left unattended at campsite or in campers.
2. Please keep campsites neat and clean and leave them in the condition you found them.
3. No profanity.
4. Intoxication will not be tolerated.
5. No trail bikes, four wheelers, skateboards, or motorized scooters.
6. Golf carts may only be operated by licensed drivers.
7. Firearms and fireworks are not permitted.
8. No cutting or damaging trees or shrubs. No holes are to be dug without permission of management.
9. No washing cars or campers or wetting roads.
- 10. Speed limit is 8 MPH.**
11. Picnic tables are not to be removed from sites.
- 12. Quiet hours are from 11:00 PM to 8:00 AM.**
13. Any complaint should be reported to the office immediately.

For our sake ...

1. Campfires must be kept in fire pits.
2. No refunds.
3. No subleasing. Management retains control of unoccupied sites until your return. Only 1 camping unit per campsite.
4. Two adults and two children under 18 per campsite. There is a \$2.00 charge per additional child under 18; \$5.00 charge per additional adult 18 and over. We ask that the registered camper be responsible for registering their guests.
5. Personal phone calls will be posted on the bulletin board at the office. Emergency calls will be delivered.
6. We will always try to reserve the site of your choice when you make a reservation; however, we cannot guarantee any specific site.
7. Payment is due at check-in by cash or credit card. If you rent for the season, you are responsible for the entire amount. If you leave early, you will be charged by the monthly rate. Sites are not pro-rated.
